

PARTY NAME

The Party Name Master requires basic information to be filled out, including the Customer Name Code, UnderGroup (if the sale party is a sundry debtor), Tax % (if the ledger name is "tax" and the under group is "duty and tax"), Address1, Address2, City, State, PinCode, State Code, GSTIN, PanNo, Distance, and Contact Person Details such as Name, Contact Number, Email Address, and Designation.

ITEM NAME

To create an invoice, you need to have a list of items with their details. A crucial detail is the Item Name Master, which is a unique code that you enter in the Part No. box. You can also add a description of the item that you want to appear on the invoice. The rate is optional, so you can change it when you generate the invoice. UOM is a field that helps you to quickly bill the item. HSN Code is also an important field that is required for government reports and uploading invoice utility JSON files.

<u>CUSTOMER PO [OPTIONAL]</u>

Customer PO is optional for a sales invoice. This document includes the party, item, and rate, allowing users to create an invoice without errors.

The sales invoice is divided into three parts: Bill To, Ship To, Time of Preparation, Mode of Transfer, Vehicle Number, and Date of Issue. Part B carries the item name, quantity, and rate to calculate the invoice value. Part C shows the tax percentage and other charges applied to the invoice. The remaining information is auto-populated on the invoice print view.
